FOR A COLUMBARIUM NICHE**

THIS RIGHT OF INTERMENT made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, by and between FUMC, Boise, hereinafter referred to as the "Church" and \_\_\_\_\_, hereinafter referred to as "Purchaser".

WHEREAS, the Church has set aside a niche area within the Cana Memorial Columbarium to memorialize those who desire interment of cremated remains and as described in this Interment Permit, and

WHEREAS, the Church has established a set of policies and rules governing eligibility and use of the Cana Memorial Columbarium, and Purchaser is familiar with the content thereof, and the said policies and rules are available at: [www.cathedraloftherockies.com](http://www.cathedraloftherockies.com) and are incorporated as if fully set out herein, and Purchaser agrees to future changes in said policies and rules may be made by the Church.

1. The Church agrees to provide to Purchaser a niche in the columbarium for the cremated remains of one or two person(s), provide a standard bronze urn(s), to have the niche inscribed with the name(s) and birth year and death year.

3. Purchaser warrants a right in and to the mortal remains of the person or persons anticipated to be interred and further warrants authority to execute this agreement. The Church assumes no responsibility to inquire further into the authority of the person executing this contract.
